

## SCHEDULE 3: PRACTICAL, CLINICAL AND PROFESSIONAL COURSES WITH FITNESS TO PRACTICE REQUIREMENTS

## 1 PURPOSE

This Schedule forms part of the Academic Progression Policy and lists courses from Schedule 2 in which students must undertake work-integrated learning that is designed and assessed with reference to relevant professional standards. Courses listed on Schedule 3 will specify and determine students' capacity to safely participate in work- integrated learning using course-specific Fitness to Practice (FTP) requirements. Course-specific FTP requirements and other regulatory requirements are applicable for the full duration of the course. Information about these requirements is available in the Macquarie University Handbook. Inability to meet and maintain FTP may lead to permanent exclusion under the General Coursework Rules.

This Schedule is reviewed annually and lists the courses commencing in the following year to the last review date.
