

Biosafety and Biosecurity Policy

Section 1 - Purpose

(1) The purpose of this Policy is to establish and maintain the safety framework for research and teaching involving microorganisms and biohazardous materials. The implementation of this Policy will facilitate compliance with relevant legislation, promote high-quality research and teaching, and minimise risks to human and animal health, and the environment.

Background

- (2) Macquarie University is dedicated to managing its biohazards in a responsible manner while maintaining its research, teaching and service missions. To this end, the University is committed to ensuring that individuals using microorganisms and other biohazardous materials are suitably trained and supervised.
- (3) All research at the University is governed by the <u>Macquarie University Code for the Responsible Conduct of Research</u>. Also applicable to all research, teaching and services involving microorganisms and biohazardous materials is the AS/NZS 2243.3:2019 Microbiological safety and containment standard. Further Acts, regulations and guidelines become applicable when dealings involve the use of GMOs, SSBAs or biological materials requiring quarantine containment. The list below highlights the legislation applicable to each of these dealings:
- (4) GMOs <u>Gene Technology Act 2000</u>, <u>Gene Technology Amendment Act 2015</u>, <u>Gene Technology Regulations 2001</u> and (commencing from 8 October 2019) Gene Technology Amendment (2019 Measures No.1) Regulations.
- (5) SSBAs National Health Security Act 2007, National Health Security Regulations and the SSBA Regulatory Scheme.
- (6) Biological Materials Requiring Quarantine Containment Biosecurity Act 2015.

Scope

(7) This Policy covers research, teaching and services involving biohazards, GMOs, SSBAs and biological materials requiring quarantine containment. This Policy applies to all persons (including Macquarie University employees, students, researchers, service providers, contract employees or any other persons) conducting any activity related to biohazardous materials on University premises or outside the geographical boundaries of the University (field research and teaching).

Section 2 - Policy

Accreditation

- (8) The University will:
 - a. maintain OGTR accreditation;
 - b. maintain internal processes to effectively monitor work involving biohazards and GMOs at the University; and
 - c. maintain an appropriately constituted IBC that is provided with the resources required for institutional monitoring.

Certification

- (9) The University will:
 - a. ensure it maintains certification of OGTR and quarantine approved premises (as defined as an Approved Arrangement site under the <u>Biosecurity Act 2015</u>);
 - b. inspect these facilities at least annually to ensure they remain compliant with current standards; and
 - c. restrict access to certified facilities to those persons who are inducted, adequately trained and have approval to enter.

Institutional Biosafety Committee

(10) The University will:

- a. maintain an IBC as required by legislation, with an agreed Terms of Reference and Procedures;
- b. ensure, through the IBC, that all research, teaching and services at the University that involve biohazards, GMOs, SSBAs and agents requiring quarantine containment are conducted in accordance with the relevant legislation, regulations, standards, guidelines and codes;
- c. provide the IBC with resources and powers to fulfil its Terms of Reference and operate as set out in the relevant legislation and guidelines;
- d. employ a Biosafety Officer and Quarantine Officer to assist the IBC in monitoring and reporting; and
- e. respond effectively to recommendations from the IBC to ensure that all biohazardous activity within the University remains in accordance with the relevant legislation, regulations, standards, guidelines and codes.

Biosafety Awareness

(11) The University will:

- a. conduct an institutional biosafety workshop at least annually for personnel involved in the acquisition, handling, storage, transport, removal or disposal of biological materials on University premises to ensure that such personnel are aware of potential risks;
- b. ensure relevant personnel are adequately trained to enable them to be considered an accredited person under the <u>Biosecurity Act 2015</u>;
- c. ensure that any research, teaching or services using biological materials are only undertaken after a risk assessment has been performed; and
- d. ensure any dealings with GMOs, use of agents classified as risk group 2 and above, SSBAs or agents requiring containment or approval under the <u>Biosecurity Act 2015</u>, have been approved by the IBC.

Review and Reporting

(12) The University will:

- a. require all persons involved in dealings with GMOs, using agents or animals containing agents classified as risk group 2 and above, SSBAs or agents requiring containment or approval under the <u>Biosecurity Act 2015</u>, to submit research applications, risk assessments, teaching protocols, progress reports and final reports to the IBC;
- b. ensure dealings with GMOs, the use of agents classified as risk group 2 and above, SSBAs or agents requiring containment or approval under the <u>Biosecurity Act 2015</u>, are not commenced without the prior approval of the IBC;
- c. ensure the IBC reviews all applications, risk assessments and reports in respect of any dealings with GMOs, use of agents classified as risk group 2 and above, SSBAs or agents requiring containment or approval under the

- <u>Biosecurity Act 2015</u>, so that they may assess the risks associated with the biological dealing being undertaken and ensure these risks have been adequately controlled;
- d. enable the IBC to conduct monitoring inspections, at least annually, of the University's laboratories in which biohazards and/or GMOs are handled to ensure compliance with the relevant legislation, regulations, standards, guidelines and codes;
- e. require the IBC to report annually to the Deputy Vice-Chancellor (Research);
- f. require the IBC to report annually to the OGTR in accordance with the Guidelines for Accreditation of Organisations 2012 and the Explanatory Information on the Guidelines for Accreditation of Organisations v 1.4 issued by the OGTR;
- g. maintain transparent procedures to manage and report any adverse events or complaints that may arise during the conduct of activity using microorganisms or biohazardous materials, in accordance with the <u>Macquarie</u> <u>University Code for the Responsible Conduct of Research</u> and the IBC Terms of Reference and Operating Procedures; and
- h. treat seriously, monitor, pursue and address any breaches.

Section 5 - Definitions

- (15) Commonly defined terms are located in the University <u>Glossary</u>. The following definitions apply for the purpose of this Policy:
 - a. Biohazard any organism or biologically derived infectious agent that is hazardous to humans or animals, or which may negatively impact the environment. Biohazardous material includes microorganisms, animals, blood, body fluids and tissues from humans and animals, cell cultures and human oncogenes.
 - b. GMO Genetically Modified Organism (as defined in Part 2 of the Gene Technology Act 2000).
 - c. IBC Institutional Biosafety Committee.
 - d. Microorganism an organism too small to be seen without the aid of a microscope e.g. virus, bacteria, protozoa, and some algae and fungi.
 - e. NLRD Notifiable Low Risk Dealing (as defined in the Gene Technology Regulations 2001)
 - f. OGTR Office of the Gene Technology Regulator which acts under the <u>Gene Technology Act 2000</u> and <u>Gene Technology Regulations 2001</u>.
 - g. Risk group a numerical classification of infectious microorganisms as defined in the AS/NZS 2243.3:2019.
 - h. SSBA Security Sensitive Biological Agent.
- (16) A reference to a legislative provision, legislation (including subordinate legislation), regulation or an Australian standard is to that provision, legislation, regulation or standard as amended, re-enacted or replaced.
