

SPECIAL CONSIDERATION SUPPORTING EVIDENCE SCHEDULE

1 PURPOSE

This Schedule provides guidance to professional and academic staff engaged in the process of determining whether a student's circumstances or events affecting assessment should be regarded as being serious, unavoidable and significantly disruptive under the Special Consideration Policy.

It also establishes minimum standards regarding the documentary evidence required to substantiate such cases.

2 SCHEDULE

Under the Special Consideration Policy, short-term circumstances or events that are serious, unavoidable, and significantly disruptive are those that:

- could not have reasonably been avoided or guarded against by the student; and
- were beyond the student's control; and
- caused substantial disruption to the student's capacity for undertaking assessment for the unit(s); and
- occurred during an event critical study period and were at least **three (3)** consecutive days duration or a total of 5 days within the teaching period, and / or
- prevented completion of an assessment task scheduled for a specific date (e.g. final examination, in class test/quiz, in class presentation).

Short-term circumstances or events that are serious, unavoidable and significantly disruptive may be unexpected in nature, including personal, social or domestic issues such as illness (either physical or psychological), accident, injury, societal demands (e.g. jury service), bereavement, family breakdown, or may be anticipated, but significantly affect the student's capacity for undertaking assessment for the unit(s), such as religious commitments, legal commitments, work commitments that cannot be changed, caring commitments.

All applications for Special Consideration must be supported by evidence as described below.

General Evidence Requirements:

Evidence must demonstrate that substantial disruption has been caused to the student's capacity for effective study during an event critical study period and must:

- identify the circumstances or events;
- include dates and/or the length of the circumstances or events;
- explain the severity and impact of the circumstances or events;
- clearly describe how the circumstances or events have adversely affected the student's capacity for effective study to which an assessment relates; and
- where relevant, include the date(s) on which the student was seen by the professional providing the evidence.

Specific Evidence Requirements:

In addition to the above general evidence requirements, the following points apply when a Statement of Fact (SoF) is used as supporting evidence:

- A SoF can be used for event categories outlined in the Schedule of Evidence if the event duration is **5 days** or fewer. If the duration is beyond **5 days**, the application will require other appropriate/independent documentation forms.
- SoF cannot be used to apply for multiple applications for special consideration for the same assessment task. Further documentation of an appropriate nature will be required which will provide independent corroboration of event and duration e.g., Medical Certificate for an illness.

<p>7. Army Reservists/SES commitments and Volunteer Firefighters/emergency volunteers</p> <ul style="list-style-type: none"> • Unavoidable training commitments or required to participate in their field. 	<ul style="list-style-type: none"> • An official training notice from organiser explaining why attendance is required or • Statutory Declaration or • a Statement of Fact.

The following are *not* considered short-term circumstances or events that are serious, unavoidable and significantly disruptive requiring Special Consideration:

- Reading the Unit Guide incorrectly
- Attending events such as:
 - Concerts
 - Talk shows
 - Sporting events
 - Protests
- Pre booked holidays
- Routine employment
- Internet outage or computer failure (certain exceptions apply, e.g. in prison/ remote or rural students)
- Heavy academic workload
- Misreading the examination timetable
- Professional Experience - organised by the student independently
- Other events or activities not related to current employment or studies, and
- Students registered with Student Wellbeing with long term circumstances such as:
 - Chronic illness/disability
 - Students with carer status.

Statement of fact can only be used for only for circumstances of 5 days or fewer and cannot be used when applying for special consideration after submission of an assessment or undertaking an examination or timed assessment

*Official letter for unavoidable commitments depend on circumstances. For example; significant religious commitments would require a letter from a religious leader or elder, a Court date or Jury Duty would require a letter confirming the date of attendance at court.
